Independent Foundation

The Catholic Community Foundation of San Diego is an autonomous pious foundation formed under canon law and is a tax-exempt nonprofit under civil law. The foundation is independent from the Diocese of San Diego and has its own board of trustees.

Donor-centricity is a core principle of the Foundation. All fund distributions from our donors are fulfilled in a manner that respects and honors each donor's funding intentions. In the service of charity, the core values of the Foundation are to:



Primary Areas of Support

Over time, parish endowments can help reduce the amount of time our parishes are required to conduct fundraising campaigns while allowing them to spend more time creating and supporting essential parish ministries.



Engaging young Catholics in Catholic K-12 education in San Diego and Imperial counties is critically important to ensure the development of future Catholic leaders in our parishes, our local communities, and our world. Funds designated for Catholic Education provide many opportunities for young Catholic students to be able to attend our Catholic schools through tuition assistance programs, and they support our Catholic schools' ability to attract and retain outstanding Catholic school administrative and classroom leaders to teach our children. Catholic education provides a great opportunity for Catholic children to develop and grow in their Catholic faith while also attaining the integrated knowledge and skills needed to help them grow into responsible global citizens as disciples of Christ.





Ongoing support for the Seminary, Religious Life, and Holy Orders and for our retired Religious is a critical function of the Catholic Church. Now, more than ever, it is very important that young Catholics hear and react positively to the call of God to prepare for and enter religious life. Our Catholic future depends on it. Types of Funds

The Catholic Community Foundation of San Diego supports 2 major types of funds: Endowment Funds and Non-Endowed Funds.

Any individual or institution can establish a new fund or add to an existing fund by making an irrevocable gift to the Catholic Community Foundation of San Diego. These funds may be tailored to fit a general or specific charitable interest. Consistent with the "donor-centric" mission of the Catholic Community Foundation of San Diego, all distributions from these funds are directed by the donor.

Endowed Funds

Endowment Funds are permanent funds intended to provide long-term support for charitable Catholic organizations. The principal for these funds is protected forever — thus allowing the fund to support its intended purpose in perpetuity, far beyond the donor's lifetime. Endowments provide a stable, predictable source of income for Catholic organizations. Earnings from these invested funds are distributed through grants in a manner consistent with the donor's designated purpose of the fund and timing of grant distributions.

Non-Endowed Funds

Non-Endowed Funds are fully-expendable, nonpermanent funds that offer a convenient and flexible way for donors to contribute to a wide variety of charitable causes. It allows a donor to make a charitable gift donation, receive full and immediate tax benefits in that calendar year and grant from that fund in the current or future years without timing or minimum payout restrictions.

Fund Categories

Following the decision to create one of these two fund types, the donor specifies one of the following four fund categories to designate the fund's specific purpose and future grant distributions:

Unrestricted Funds

These funds may be used to provide grants for any purpose consistent with the charitable mission of the foundation, as determined by its Board of Trustees.

Donor-Advised Funds

These funds are established by donors who have a range of charitable interests and wish to participate in the future grant-making process for the fund. The recommended organization must operate in a manner consistent with Catholic values.

Designated Beneficiary Funds

These funds are established for specific religious, educational or charitable organizations that are near and dear to the heart of the donor. Grant distributions are made to the designated organization, consistent with the specific intent of the donor.

Field Of Interest Funds

These funds are intended to address needs of an important area of focus for religious, educational or charitable organizations.

Currently, the foundation has 7 existing Field of Interest Funds.

- Faith Formation and Parish Life Fund
- Peace and Justice Fund
- Retired Priests and Religious Fund
- Sanctity of Life Fund
- Service to the Poor Fund
- Vocations Fund
- Youth and Education Fund


Donor Recognition

Investment Policy

The Foundation only supports organizations whose activities are consistent with our Catholic Values. All of the funds entrusted to the Catholic Community Foundation of San Diego are invested in a manner consistent with the Catholic Values Investing (CVI) standards that are set by the United States Conference of Catholic Bishops. You can also be assured that all fund distributions will only be distributed to charitable organizations whose mission and values are consistent with our Catholic faith.
